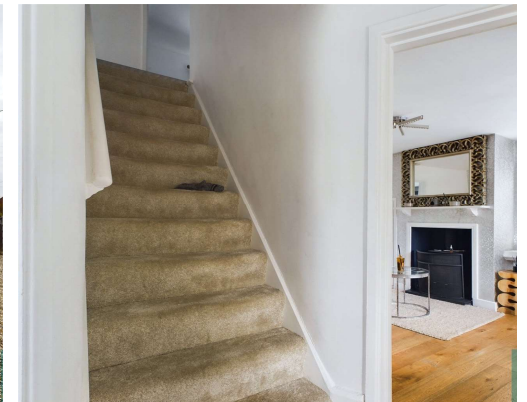

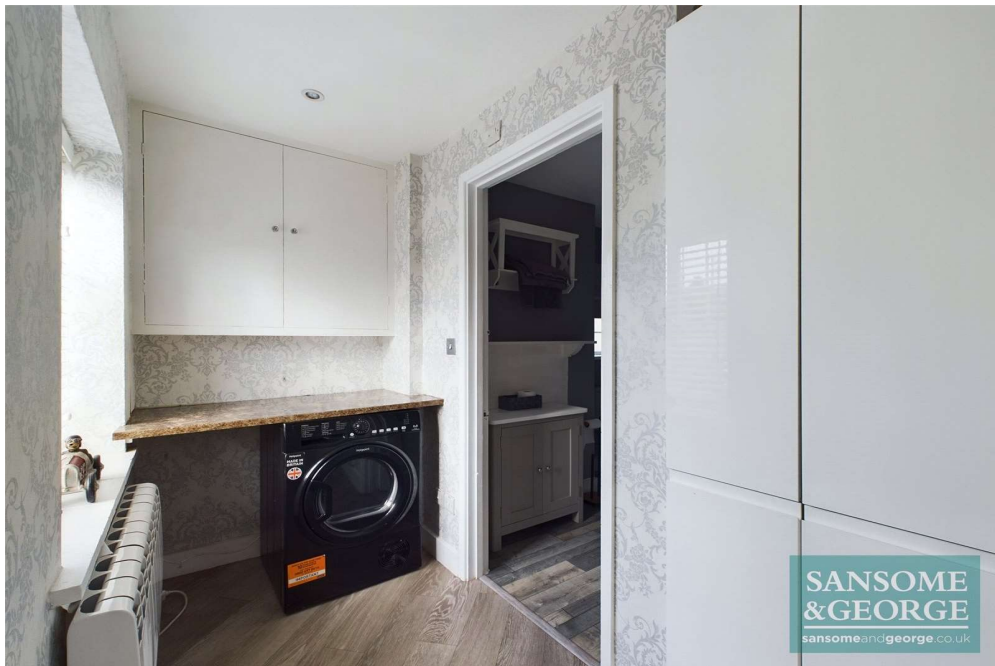

**Floor 0** Building 2



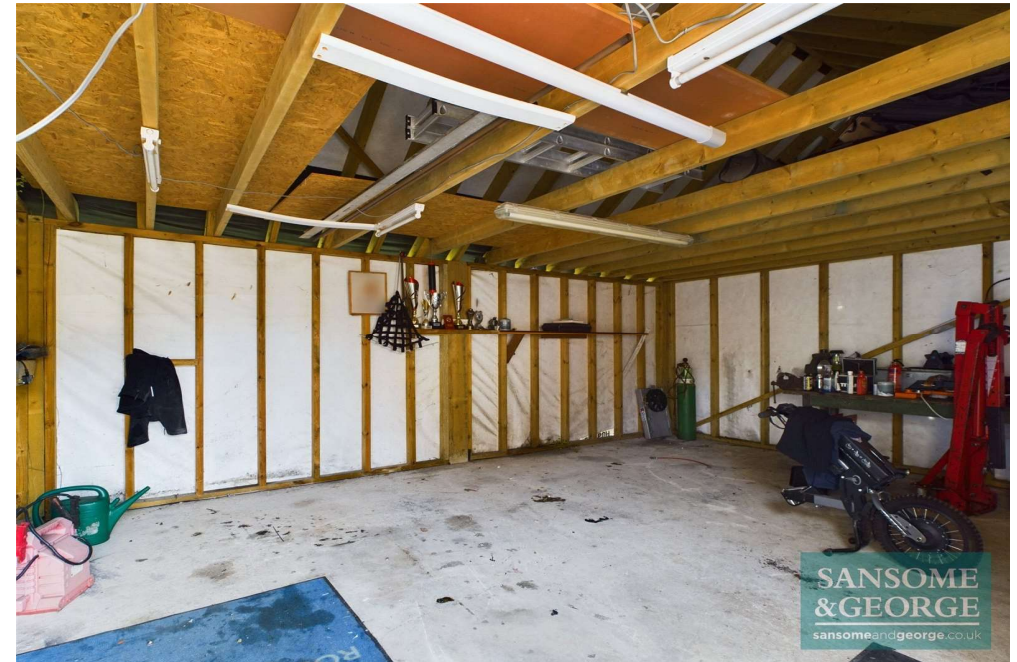
